A. Any person who violates a community standard shall pay the fine as set forth herein for each offense, plus all direct and indirect costs incurred by the Borough for the cleanup and abatement of the violation, as per CSO #676 of 2019.

B. Every day that a community standard violation continues shall constitute a separate offense. The application of the above penalty shall not be held to prevent the enforced removal of prohibited conditions nor permit them to continue. When repeat community standard violations are identified on the same property or different properties owned by the same person, it shall be considered a repeat offense and the penalties will increase as indicated above.

C. Any persons who receive a violation ticket for any community standard violation may, within fifteen (15) days, admit the violation by signing below, waive a hearing, and pay the fine in full satisfaction.

D. Failure to remit payment or request a hearing within fifteen (15) days, shall result in an imposed late penalty. Failure to remit payment or request a hearing within thirty (30) days, shall result in the filing of a citation with the District Magistrate.
